The Council are therefor is granted on application made under the Town and Country Planning further of the opinion that development of the said description would constitute (eneral Development Order 19.77 (as amended).

NOW THEREFORE the Council in pursuance of the powers conferred upon them by the said Article 4 hereby direct that the permission granted by Article 3 of the Town and Country Planning General Development Order 1977 (as amended) by the Town and Country Planning General Development (Amendment) Orders of 1981, 1983 and 1985 shall not apply to development on the Land of the description set out enin Schedule I hereto.



SCHEDULE I

1. The use of land (other than a building or the curtilage of a building) for any purpose or purposes except as a caravan site on not more than 28 days in total in any calendar year and the erection or placing of moveable structures on the land for the purposes of that use being development comprises within Class IV. Para 2 referred to in the First Schedule to the said order and not being development comprised within any other Class in so far as it relates to the use of the land for clay pigeon shooting and artificial target shooting.


