PERMITTED DEVELOPMENT) DIRECTION 1971

WHEREAS the Urban District Council of Farnham (hereinafter called "the said Council") acting in the Urban District of Farnham on behalf of the Surrey County Council, the Local Planning Authority, are satisfied that it is expedient that development of the descriptions set out in the schedule to this direction should not be carried out in the curtilage of West Cottage, School Hill, Wrecclesham, Farnham shown edged red and coloured pink on the plan annexed hereto (hereinafter called "the said land") unless permission therefor is granted on an application made under the Town and Country Planning General Development Orders 1963 to 1969

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1963 (hereinafter called "the said Order") hereby direct that the permission granted by Article 3 of the said Order shall not apply to any development on the said land of the descriptions set out in the schedule hereto

This direction may be cited as the Farnham Urban District Council (West Cottage, School Hill, Wrecclesham) (Restriction of Permitted Development) Direction 1971

SCHEDULE

The erection, construction or placing of a garage on the said land or the enlargement, improvement or other alteration to the original dwellinghouse on the said land to form a garage being development within Class I of Schedule 1 of the said Order

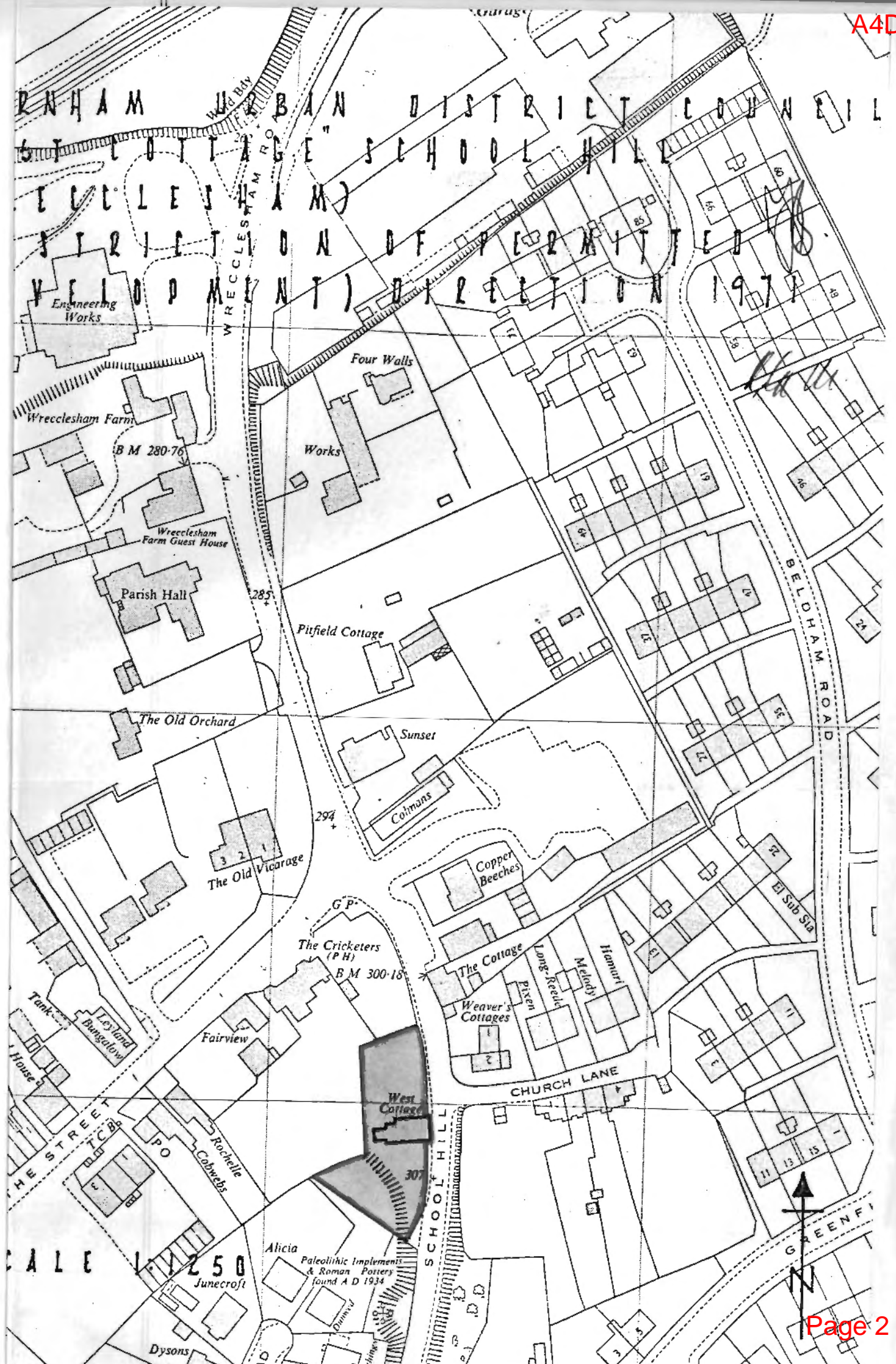




